HWCIT CLAIM REPORTING PROTOCOLS FOR MEMBERS

For injuries occurring within the State of Louisiana at a licensed racetrack or training facility: Immediately report the injury to the nearest designated LAHBPA Field Office listed below.

For injuries occurring within the State of <u>Louisiana</u> at a place OTHER THAN a licensed racetrack or training facility (i.e., farms):

- Refer or take injured employee for medical treatment to a recommended network medical facility.
- Contact the medical facility to request a drug screen of the injured employee at initial visit.
- <u>Immediately</u> report the injury to Gallagher Bassett Services (TPA) at <u>(225) 372-3951</u>, ask for the Louisiana Horsemen (HWCIT) Adjuster.
- <u>Immediately</u> report the injury to the nearest LAHBPA Field Rep listed below.

For injuries occurring OUTSIDE the State of Louisiana at a licensed racetrack or training facility:

- Refer or take injured employee for medical treatment to nearest medical facility
- Contact the medical facility to request a drug screen of the injured employee at initial visit.
- Immediately report the injury to a LAHBPA Field Rep listed below.
- <u>Immediately</u> report the injury to LAHBPA main office at <u>(504) 945-1555</u>, ask for Michael Fenasci.
